The details regarding qualifications, experience, screening guidelines and indicative proforma etc. are available on the site along with the advertisement. The applicants are required to read these details carefully before filling up the form.
3. **Applicants are required to take 4 sets of print-outs of the Online Application Form filled by them and attach hard copies of the supporting documents (i.e. Educational Qualifications, Employment Experience, Category (if any), NOC (if any), Research Details, Academic Activities etc.) with each print-out as per the Annexures mentioned in the Online Form. 4. Applicants must attach all the documents related to their research activities/ other activities in support of their claim. At least the first/relevant page of each research paper/book/ publication indicating name(s) of authors, name (s) of Journal/Book with ISSN/ISBN number is necessary to be attached, without which no credit will be given for the research paper/ book /publication.
